**Re: 2019 Lake Tahoe Water Use Inventory**

In December 2015, the Truckee River Operating Agreement (TROA) was implemented. Part of this agreement specified how the water use in the Tahoe Basin would need to be reported. The Division of Water Resources is responsible for providing an annual water use report per Public Law 101-618 paragraph 204(d)(1). Paragraph 204(b) provided guidance on how the water is to be accounted for. This guidance was used for this 2019 report except in the following instances:

- Permits 68940 through 68943 and Permits 72124 and 72125 were issued to the US Forest Service to maintain instream flow. These permits are considered non consumptive uses; therefore, the State of Nevada listed these permits as a zero use against the basin.
- Permits 11870, 13445, 18332, 18333, and 18334 are currently under non-use noticing by this office pursuant to NRS 534.090. These rights are shown as having no use.
- The newer permits that have not had a proof of completion submitted per NRS 533.380; therefore, there is no point of diversion for the water to be utilized by the permittee. These rights are shown as having no use against the basin.

## **ABSTRACT**

The Lake Tahoe basin straddles the Nevada-California state line with approximately two-thirds of the basin in California and one-third in Nevada. In the late 1960's, an Interstate Compact between the two states was drafted and ultimately ratified by both states. The Compact set forth provisions for the equitable apportionment of waters between the two states. The provisional annual allocation of the waters of the Lake Tahoe Basin for the State of Nevada and for the State of California is 11,000 and 23,000 acre-feet, respectively, for use within their portions of the Lake Tahoe Basin. Water collected after its use (e.g., effluent) does not count against the allocation to either state and may be exported out of the basin. Although Congress never approved the Compact, provisions from the Compact were inserted and affirmed in the passing of Public Law (PL) 101-618 (Settlement Act) on November 16, 1990.

PL 101-618 required that a new Truckee River Operating Agreement (TROA) be implemented before the provisions for the interstate allocations of PL 101-618 could take effect. TROA was conditionally approved in 2008; however, implementation was delayed pending resolution of all remaining conditions. TROA was officially implemented in December of 2015. Both the California-Nevada Interstate Compact and PL 101-618 exclude trans-basin deliveries existing prior to December 31, 1959. These trans-basin deliveries allow up to 2,753 acre-feet from Permit 11624, Certificate 4217 sourced from North Creek and Tributaries; 561 acre-feet from Permit 23017; and 3,000 acre-feet from Permit 30896 sourced from Marlette Creek.

For the water year 2019 (October 1, 2018 through September 30, 2019), the estimated use of water from groundwater and surface water sources within the Lake Tahoe Basin per TROA totaled 7,968 acre-feet. Municipal and quasi-municipal use is the largest manner of water use.

<sup>2</sup> Committed water resource data are accurate for October 2019. Manner of use category totals vary over time, as rights are not static. Rights may be subject to change applications, certification, withdrawals, forfeiture and cancellations; each of these circumstances could affect the duty, diversion rate and acreage associated with a given right. The value associated with each manner of use category does not include the amount relinquished in support of domestic wells. A query of the NDWR Well Log Database indicates that 93 domestic wells existed in the basin during water year 2019, seven of which are permitted. The committed domestic water resource is considered to be 2 acre-feet per exempt domestic well. Permitted domestic well and surface water duties were added to the exempt domestic well commitment value for a total of 293 acre-feet annually.

## **PURPOSE**

The Nevada Division of Water Resources (NDWR) satisfies its responsibility to report water usage for the Nevada side of the Lake Tahoe basin to the TROA Administrator with this report. The report is completed annually in order to comply with TROA and to ensure Nevada's 11,000 acre-foot annual allocation from Lake Tahoe, set forth in Public Law (PL) 101-618 (Settlement Act), is not being exceeded. This report inventories all water allocated by the Office of the State Engineer, NDWR, which includes all permitted and certificated rights, vested claims, and exempt domestic wells within the Lake Tahoe Hydrographic Basin (6-090). This report is due to the Administrator by September of each year per PL 101-618.

## **DESCRIPTION OF THE STUDY AREA**




Figure 1. Physiographic map of Lake Tahoe Basin (Hydrographic Basin 6-090).

The Lake Tahoe Hydrographic Basin spans both California and Nevada, and occupies approximately 139 square miles in Washoe County, Douglas County, and Carson City in Nevada (Figure 1). The adjacent hydrographic basins are Truckee Canyon Segment (6-091) to the north, Washoe Valley (6-089) to the northeast, Eagle Valley (8-104) to the east, and Carson Valley (8-105) to the south. The boundary of the Lake Tahoe Hydrographic Basin is as described by Designation Order 956 issued by the Nevada State Engineer on November 25, 1987.

The Lake Tahoe Hydrographic Basin is bounded on the west by the Sierra Nevada Range and the Carson Range to the east. About one-third of the basin is in Nevada and two-thirds is in California. Mountain peaks rise to more than 10,000 feet above sea level. The surface of Lake Tahoe, which serves as a source for the Truckee River, has an average elevation of about 6,225 feet. The river exits the lake on the northwest side in California, and flows to its terminus at Pyramid Lake, in Nevada.

The U.S. Geological Survey (USGS) operates several stream gaging stations within the Lake Tahoe Hydrographic Basin. In Nevada, Station 10336693 is located on Wood Creek, Station 10336698 is located on Third Creek, Station 10336700 is located on Incline Creek, Stations 10336710 and 10336715 are located on Marlette Lake and Creek (respectively), Station 10336730 is located on Glenbrook Creek, and Station 10336760 is located on Edgewood Creek. ## **METHODS TO ESTIMATE WATER USAGE (TROA SPECIFIC)**

One of the purposes of this report is to estimate the amount of water diverted from surface and groundwater sources under permits, certificates, and vested claims issued by the State Engineer, as well as the amount pumped by the exempt domestic wells in the basin. The following methods were used to arrive at the estimated use in relation to TROA Section 6.D. According to these methods, water usage is summarized in Table 1 and shown in greater detail in Tables 2 and 3.

### **1. Section 6.D.2 Measurement Requirements**

NDWR performs a yearly pumpage inventory for Nevada's portion of the Lake Tahoe Basin based on the water year (October 1, 2018 through September 30, 2019). In order to gather annual inventory data, NDWR staff visit points of diversions, read meters, perform crop inventories, and gather and verify pumpage reporting from water purveyors, snowmaking operations, and public agencies per section 6.D.2.

### **2. Section 6.D.3 Unmeasured Residential Uses**

As part of the yearly inventory, NDWR maintains a list of which residential users are metered and un-metered. The un-metered users are assumed to use four-tenths of an acre-foot per residential unit per Section 6.D.3. NDWR reads all the residential meters as part of the annual inventory and the results are recorded and displayed in this report. Table 2 shows the reporting results. Appendix A documents pumpage by application number for permitted residential uses.

### **3. Section 6.D.4 Unmeasured Non-Residential Uses**

All non-residential water uses that are not metered are assumed to use their permitted duty. Unmetered water use in the Lake Tahoe Basin may exist for environmental, irrigation, recreation, commercial, and stockwater permits. Supplemental groups of water right duties are accounted for within the report's numbers. Fully non-consumptive permits such as "in-stream" environmental uses do not count against Nevada's allocation of 11,000 acre-feet annually (AFA). Table 2 shows the reporting results. Appendix A documents pumpage by permit application number.

#### 4. Section 6.D.5 Diversions into a Distribution System<sup>3</sup>




Figure 2. Map showing the Lake Tahoe water purveyor service areas.

The single largest use of water in the Lake Tahoe Basin is for municipal and quasi-municipal purposes. Seven purveyors hold the majority of the permits issued for municipal and quasi-municipal use (Figure 2). From north to south, these purveyors are as follows:

1. Incline Village General Improvement District (IVGID)
2. Glenbrook Water Cooperative (Glenbrook)
3. Logan Creek General Improvement District (LCGID)
4. Douglas County (Uppaway, Cave Rock/Skyland, Zephyr Cove)
5. Round Hill General Improvement District (RHGID)
6. Kingsbury General Improvement District (KGID)
7. Edgewood Water Company (Edgewood)

The purveyors supply most of the information on diversion totals for their individual permits. NDWR verifies the provided meter readings during field investigations. The reporting from the purveyors is based on a calendar year, which differs from the water year inventory that NDWR collects. For the purposes of this report, reported calendar year usage is assumed to be a reasonable estimate of water year usage.

Section 6.D.5 of TROA and Sections 204(b)(2)(C)(i) and (ii) of PL 101-618 (Settlement Act) allow NDWR to report usage as measured at the end users' water meters instead of total supply pumped as measured at the point of diversion. Reporting the usage rather than pumpage is only allowed if the purveyor has a State-approved water conservation plan and has end user water meters throughout its system. The benefit of reporting usage instead of pumpage is that the water loss (unaccounted-for water) does not count against Nevada's allocation of 11,000 acre-feet annually from Lake Tahoe, per the Settlement Act Section 204(b)(1). Table 2 shows the reporting results.

## 5. Section 6.D.6 Snowmaking – Lake Tahoe Basin

Section 6.D.6 of TROA allows for up to 350 acre-feet annually for snowmaking purposes that do not get charged against Nevada’s gross diversion allocation for the Lake Tahoe Basin within Nevada. For any diversions above the 350 acre-feet limit, or any diversions that leave the basin, 16% of that diversion is charged against Nevada’s gross allocation. Snowmaking permits 58344 and 87125, issued to IVGID and Heavenly Valley respectively, purposely cap the amount that is allowed to be diverted to a maximum of 350 acre-feet. Permits 79612 and 79613 were issued to Heavenly Valley for snowmaking with a total combined duty of 592 acre-feet annually. The point of diversion for these two permits is from Edgewood Water Company’s intake in Nevada, but a place of use was issued for the California side of the Lake Tahoe Basin. Per Section 6.D.6 (a), the previously mentioned 16% charge of water shall be charged to the Lake Tahoe allocation of the state where the snow is deposited.

Heavenly and IVGID provided the snowmaking numbers used for this inventory report. IVGID’s snowmaking has one meter and is all applied within the Nevada side of the Lake Tahoe basin. The usage is based on a calendar year reporting, which differs from some of the other pumpage totals that NDWR collects. Heavenly is in the process of clearing up permitting issues associated with crossing state lines, as well as moving the points of diversion to best match the actual location of snowmaking. The efforts to better depict water use for snowmaking will be reflected in future reports. Per Section 6.D.6(c) there is an exemption for out-of-basin transfers of water for snowmaking if the diversions were occurring prior to May 1, 1996. Table 3 shows the reporting of snowmaking required by Section 6.D.6.




Figure 3. Lake Tahoe Basin historical TROA pumpage by manner of use.




Figure 4. Percentage of 2019 water pumped by manner of use.

**EXPLANATION OF COLUMN HEADINGS FOR WATER USE INVENTORY**

- APP NO.** The file number of the Application or the Vested Claim of Right.
- SITE NAME** An ID assigned to each well, based on its geographic location.
- STATUS** Indicates the status of the application if a Vested Claim of Right (VST), Cancelled (CAN), a Permit (PER). If it has been certificated, the Certificate number will be listed.
- MOU** The manner of use of the appropriated water.  
 COM - Commercial                      CON - Construction                      DOM - Domestic  
 ENV - Environmental                      IND - Industrial                      IRR - Irrigation
