Introduction

In this age of accountability, programs are required to demonstrate positive impact or results rather than process engagement. This is especially true of programs operated through public funds such as Nevada's statewide system of early intervention services for infants and toddlers with disabilities and their families. Ensuring the program has provided services does not mean the desired outcomes have been achieved. Likewise, satisfaction with services provided does not ensure the outcomes have been met. Determination of whether the desired outcomes have been achieved is based on the impact the provision of services has in improving the function of the child and family.

Nevada's statewide system of early intervention services operates in accordance with requirements established under Part C of the Individuals with Disabilities Education Act (IDEA). The U.S. Office of Special Education Programs (OSEP) administers states' Part C grants and requires each state to collect data on specific outcomes for families receiving early intervention services on an annual basis. This data is to be gathered from families who have participated in early intervention services for at least six (6) months. The results are then analyzed, and the results reported in the state's Annual Performance Report (APR). Given the program's emphasis on family-centered services, OSEP specifically requires states to determine whether families report that participating in early intervention services has helped them to:

- 1. Know their rights under the IDEA
- 2. Effectively communicating their children's needs
- 3. Assist their children with development and learning

The IDEA Part C Office, as Lead Agency for the statewide system of early intervention services, collects, analyzes and reports Family Outcomes data through an Annual Survey of families who have been enrolled in early intervention services for at least six (6) months. The results of the survey are used to:

- Determine whether participation in early intervention service has been effective in achieving the specific outcomes identified by OSEP;
- Provide data to fulfill mandated requirements for reporting to OSEP, the Governor, policy makers and the public on performance at the State and provider level relative to the identified outcomes;
- Evaluate the system's effectiveness relative to additional indicators identified by a group of Nevada's early intervention system stakeholders;
- Demonstrate the benefit of the early intervention system to families and society as a whole; and
- Support monitoring and program improvement to ensure positive results for children and families.

Provision of Early Intervention Services

Nevada has designated the Aging and Disability Services Division (ADSD) as the entity responsible for administering the provision of direct services in accordance with the IDEA requirements. For the state fiscal year (SFY) 2019, the ADSD fulfilled this responsibility through a combination of state-operated programs and contracted provider agencies providing a comprehensive program of early intervention services. This included four (4) State operated programs - Nevada Early Intervention Services (NEIS) programs with offices in the southern, northwestern, and northeastern regions of the State. The state-operated programs provide early intervention services but also serve as the Point of Entry (POE) for the service system in their respective regions. In addition, there were nine (8) early intervention programs operated through private community partner agencies in the northwestern and southern regions. Providers within each program are expected to provide multidisciplinary, comprehensive, family-centered early intervention services in natural environments. The statewide distribution of programs is as follows:

The Family Outcomes Survey Instrument

Nevada's Family Outcomes Survey instrument was designed to meet federal requirements; however, it is also designed to provide opportunity for families to give feedback on the effectiveness of the early intervention system in responding to the needs of their family. The survey instrument was developed by a task force that included family members and representatives from the Nevada Disability Advocacy and Law Center (NDALC), Nevada Parents Educating Parents (Nevada PEP), The Nevada Center for Excellence in Disabilities (NCED), Nevada's IDEA Part C Office, NEIS programs, Early Childhood Special Education, faculty from the University of Nevada, Reno (UNR), and Mental Health Services. The original survey was developed in 2006. At the request of the IDEA Part C office and the Nevada Early Intervention Interagency Coordinating Council (ICC), revisions were made in 2008, 2009 and in 2017. A stakeholder workgroup was convened in February 2017 to begin a review and revision of the survey instrument. Technical support for the 2017 revision of the survey instrument was provided through the National Center for System Improvement (NCSI) and was implemented in March 2018 to conduct the State's 2018 Annual Family Outcomes Survey. The revised survey was changed from 20 close-ended questions to 17.

Survey Method

The 2019 Annual Family Outcomes survey continues to have 17 close-ended questions and use the five-point Likert scale (strongly agree, agree, undecided, disagree, and strongly disagree). As with all previous versions of the survey, there is one open-ended question to allow families to provide a written comment and families still have the option of not answering questions if they feel they are not applicable. The survey was printed and distributed in both English and Spanish.

To ensure the data is representative of the demographics of the State, the IDEA Part C Office used the Tracking Resources and Children (TRAC) database to obtain the names and addresses of all families in the early intervention system who had a child with an IFSP for a minimum of six months and was receiving early intervention services from one of the state or community early intervention programs as of January 19, 2019. A total of 1,775 children met this criteria and these families were sent a survey for each child in the home enrolled in early intervention services. On March 1, 2019, the survey was mailed to all eligible families. A cover letter accompanied each survey, as well as a postage-paid return envelope. The cover letter informed families their survey would be returned to the IDEA Part C Office and all responses would remain confidential. Families were also provided the option to complete their survey on-line through SurveyMonkey. If a family had provided their email address and it was entered into the TRAC data system, they were also emailed a copy of the cover letter and survey. Families were asked to answer the survey questions and return them by April 22, 2019. Local early intervention programs were notified by email of the date the surveys were mailed to families and were asked to encourage families in their program to respond to the survey. The following is a breakdown of the number of surveys by early intervention program/region included in the original mailing:

Survey Responses

Based on the initial mailing, it was determined the addresses in the TRAC data system for 65 families were invalid. They are not included in the final count because these households never received a survey. Therefore, the final total for distribution of the survey was 1,710. A follow-up reminder was sent to families who had not responded the second week of April 2019 asking them to complete the survey and offered the option to contact the IDEA Part C Office for another copy of the survey, to submit their survey via email or to complete their survey via SurveyMonkey. A child specific code was provided to each family to ensure one survey was completed per child. The final total of unduplicated survey responses was 223. One hundred and sixty-eight surveys were received by mail and fifty-five responded via SurveyMonkey. This is a return rate of 13% which is a decrease of 5.7% over last year.

The percent of statewide responses received for each region was consistent with the percent distributed for each region. The rate of survey return by region was also relatively consistent with the statewide rate of return with the exception of the northeast region. The northeast region was much higher than the statewide response.

The southern and northwest regions were slightly lower than the statewide response. Compared to last year, these two regions report a decrease rather than increase and conversely the northeast region reports an increase rather than decrease. The differences could be related to the lack of responses this year as compared to last.

Table 4 below provides a breakdown of the distribution of surveys and responses received by Race/Ethnicity per federal categories. The data compares the percentages of the statewide survey distribution and response for each race/ethnicity as well as the rate of return for each category. The percent of statewide responses were slightly higher than the percentage for distribution in the White, Asian and Two or More Races categories. The remaining categories were slightly lower in percent of responses compared to distribution percentages. It has not been determined whether the differences are statistically significant.

Survey Results

The data summarized in this report from the closed-ended questions reflect the statewide averages for each question. Three (3) survey questions are specifically designed to support requirements for annual reporting to OSEP on family outcomes. The State has established annual performance targets for federal reporting purposes. The following reflects the survey questions utilized for federal reporting and the targets for the reporting period corresponding to this report.

Families generally agreed or strongly agreed with the three federally mandated questions on the survey. For questions related to understanding their rights under IDEA, <u>96%</u> (215/223) of the families responding to the 2019 survey agreed with the statement, *My IFSP team helps me know my parent rights regarding early intervention services (the procedural safeguards that are in the parent handbook).* Performance did not meet the State's target of 97.5% for this reporting period and is lower by 1% compared to the 2018 survey. There were 5 families indicating they were undecided regarding this question.

Regarding the impact of participating in early intervention services on helping them to support their child's development, <u>95%</u> (212/223) of responses were favorable for the statement: "*The early intervention services* we received have helped me effectively communicate my child's needs." Performance for this statement did not meet the state target of 96.5% and is lower by 1% compared to the 2018 survey. A total of 5 families indicated they were undecided regarding this question. Of families responding to the statement: "My Early Intervention providers have supported me in knowing how to help my child develop and learn", <u>92%</u> (206/223) responded favorably. Performance for this statement did not meet the State target of 94.5% and is considerably lower than the 96% reported on the same question in the 2018 survey.

The remaining survey questions asked the family to evaluate other critical areas of early intervention services based on their experience with their service providers. Areas addressed include:

- Respecting their values, culture, daily routines and lifestyle;
- Recognizing and promoting their role as decision maker on behalf of their child;
- Helping them to understand the early intervention services system and providing information about, and/or assisting them in accessing resources and supports;
- Providing services required by the IFSP; and
- Ensuring early intervention services has a positive impact on their child's development.

Overall, for the 2019 Family Outcome Survey, families indicated they agreed or strongly agreed with questions between 90% and 98% of the time. Out of the 17 questions the percent of families indicated they strongly agree/agree are as follows:

- For three (3) questions, 98% of families indicated they Strongly Agree/Agree
- For two (2) questions, 97% of families indicated they Strongly Agree/Agree
- For five (5) questions, 96% of families indicated they Strongly Agree/Agree
- For three (3) question, 95% of families indicated they Strongly Agree/Agree
- For one (1) question, 92% of families indicated they Strongly Agree/Agree
- For two (2) question, 91% of families indicated they Strongly Agree/Agree
- For one (1) question, 90% of families indicated they Strongly Agree/Agree

Statewide, the response to question 15 (*My early intervention providers give me information about other activities and services in the community that may help me and my child (for example, childcare, playgroups, WIC etc.)* was 90%, which is a decrease of 3% from the 93% reported last year. Historically, the responses to this question has consistently fallen below 90% with the exception of 2018 when it was 93%. Of the 223 families who completed the survey, 11 responded as "undecided" on this question. This number is also consistent with previous reporting periods.

Responses to Open-Ended Question

Of the 223 survey responses received, 123 families (55%) included a written response to the open-ended question. The number of respondents providing written comment, both statewide and by program, is as follows:

As reflected in Table 6, responses to the open-ended comments across programs were predominantly positive. Many families indicated they felt supported by early intervention services and believed participation in early intervention services had a positive impact for their child and family. Parents used descriptors such as "outstanding, amazing, knowledgeable, wonderful, fabulous, excellent, awesome, nice, patient, kind, loving, friendly, caring, phenomenal, pleasant, expert, professional, encouraging, truthful, hardworking, and helpful" to define the characteristics they saw from their early intervention providers. Many of the responses expressed thanks for the program and all it provided to children and families. Some families included positive comments but also identified areas they felt needed improvement. Some respondents used the open-ended question to identify specific concerns or challenges they experienced in participating in early intervention services including infrequent services, frequent changes in service providers, and inconsistent communication.

Comments by Program and Region

Many of the responses to the open-ended question identified specific providers who had been instrumental in delivering services that were appreciated by the families. Individual provider and children's names along with any family specific information were redacted from the report to maintain individual family anonymity. The following section reflects the comments as submitted by the respondents with the exception of the redacted information.

ADVANCED PEDIATRIC THERAPIES (APT)

- [Our service providers] from Advanced Pediatric were just amazing to our family. [They] helped our family so much and truly are a blessing to this community.
- Thank you for all that you do!
- [Our DS] has been exceptional at helping [my child], giving suggestions and ideas to better help redirecting day to day activities that help my family be more cohesive. My [child] has blossomed. Thank you.

EASTER SEALS NEVADA – SOUTH (ESN-S)

- Early Intervention Services (Easter Seals) has been very helpful to my family. [Our DS] has been outstanding with my [child], even on bad days. [She] goes above and beyond. I am so thankful for her open mind and dedication. [She] is the best.
- Our DS has been an angel to our family. Our child is improving. Thank you.
- Great resource, helped us navigate the needs of [our child] and supported us through health challenges, helmet needs, and physical therapy requests.
- I am disappointed we cannot be keep our Physical Therapist.
- I wish more people would know/and take advantage of the services that you provide.
- Only thing I DID NOT like was that the therapists only come 1-3 times per month. I don't believe that's a sufficient amount of session time. More sessions would have benefited my child.

Early intervention has made such an impact in our family, but most of all have helped me in understanding my child's special needs. This includes sensory issues, speech as well as giving me ideas [on feeding]. My sincerest gratitude for pushing [my child] to be the best.
- The providers from Easter Seals have been amazing in my child's development. I am so thankful for their support through this time.
- The team working with my child is awesome. The only thing I would change is having more time; only seeing a speech, etc. twice a month is not enough. I realize this is a funding issue. Once or twice a week would be ideal.
- The turnover rate is very high, and I still have NO answers as to why [my child] will not speak, NOR do I have any reasons still. I was never able to speak to an autism specialist. My child was declined for behavioral services, and my requests for a recommendation or referral to a neurologist since I kept being told it was a processing issue went unheeded. My developmental and Occupational therapist were great, but after 18 months of speech, I saw no progress due to services and a high number of providers.
