This budget contains 1 funds, including Debt Service, requiring property tax revenues totaling \$ 132,829

The property tax rates computed herein are based on preliminary data. If the final state computed revenue limitation permits, the tax rate will be increased by an amount not to exceed 1. If the final computation requires, the tax rate will be lowered.

This budget contains 4 governmental fund types with estimated expenditures of \$ 1,228,247 and 1 proprietary funds with estimated expenses of \$ 1,065,132
