## CORRECTION NOTICE

### Smith Valley (Hydrographic Basin 9-107)

Nov. 16, 2023

Pumpage amounts for certain permits have been updated for the calendar years 2016 through 2020. The corrected values by site can be found in Appendix B of the 2021 Smith Valley Pumpage Inventory Report. Data in Appendix B of the 2021 report supersede previously published values. The table below reflects the updated pumpage totals by manner of use, with updated values marked in orange. The corrections were made based upon various factors:

- Meter readings reported late
- Meters replaced during the year
- Field inspections identified reporter or staff error
- Adjustments for estimates where wells were pumped with broken meters
- Locked/inaccessible pumphouses prevented collection of meter readings during the inventory period
- Adjustments for wells pumped during November and December (after meter readings had been taken in the field)

## ABSTRACT

This inventory represents the status and usage of all permitted, certificated, and claims of vested right groundwater rights located within Smith Valley, Hydrographic Basin 9-107, for calendar year 2020 (January 1, 2020 through December 21, 2020). Also included are tables, graphs, and data associated with this use.

The data presented are valid for the period of this report and may vary from previously published figures as appropriations are subject to administrative action, such as transfer, certification, cancellation, forfeiture, relinquishment, or withdrawal on a continuing basis.

For calendar year 2020, the committed groundwater resource totaled 57,826 acre-feet, with estimated pumpage of approximately **34,664 acre-feet**. This figure includes an estimated 842 acre-feet pumped from exempt domestic wells.

Irrigation is the largest manner of use within the basin. For calendar year 2020, pumpage for irrigation water use totaled 32,991 acre-feet, with appropriations totaling 54,504 acre-feet. The second largest manner of use was pumping by exempt domestic wells, estimated at 842 acre-feet.

<sup>2</sup> Committed groundwater appropriations are for October 2020. Data are not static, as rights are subject to transfer, certification, withdrawal, forfeiture, relinquishment and cancellation. A query of the NDWR Well Log Database indicates that 842 domestic wells (representing both appropriative and exempt domestic wells) existed in the basin during 2020. The committed groundwater resource total includes 2 acre-feet per domestic well, or 1,684 acre-feet.

## PURPOSE AND SCOPE

The purpose of this report is to inventory all of the groundwater resources allocated and described by the Office of the State Engineer, Nevada Division of Water Resources (NDWR). The estimated amount of groundwater pumped under permits, certificates, vested claims, and exempt domestic wells within Smith Valley, Hydrographic Basin 9-107, for calendar year 2020 is described in the following sections.

## DESCRIPTION OF THE STUDY AREA

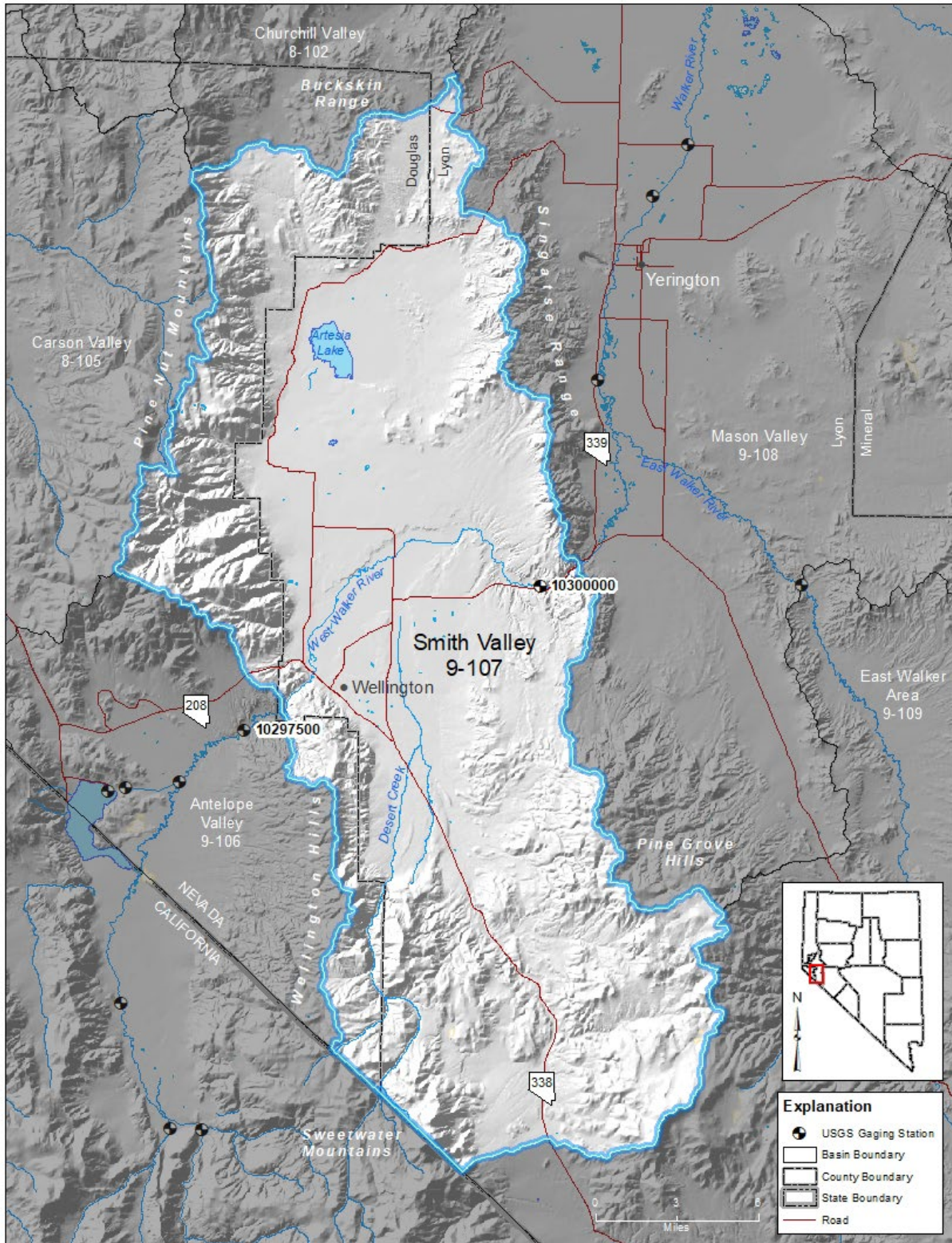


Figure 1. Physiographic map of Smith Valley (Hydrographic Basin 9-107).

Smith Valley is in west-central Nevada and east-central California. This report deals only with the Nevada portion of this basin. The Nevada portion of Smith Valley occupies approximately 464 square miles within Lyon and Douglas counties. The adjacent hydrographic basins are Antelope Valley (9-106) and Carson Valley (8-105) to the west, Churchill Valley (8-102) to the north, Mason Valley (9-108) to the east, and the East Walker Area (9-109) to the east and south (Figure 1). The Smith Valley basin boundary is described by State Engineer's Orders 245 and 1177, dated June 27, 1960 and July 8, 2005, respectively.

Smith Valley is bounded on the north by the Buckskin Range, to the east by the Singatse Range and the Pine Grove Hills, to the south by the Sweetwater Mountains, and to the west by the Wellington Hills and the Pine Nut Range.

The dominant hydrologic features of Smith Valley are the West Walker River and Desert Creek. The West Walker River flows northeasterly across the middle of Smith Valley and continues into Mason Valley where it joins the East Walker River. Desert Creek originates in the Sweetwater Range at Lobdell Lake within the southern portion of Smith Valley in California and flows north to join the West Walker River in south-central Smith Valley.

The U.S. Geological Survey (USGS) operates two streamflow gaging stations on the West Walker River near the locations where the river enters and exits Smith Valley, stations #[10297500](#) (West Walker River at Hoye Bridge) and #[10300000](#) (West Walker River at Hudson, NV), respectively.

## GROUNDWATER LEVELS

Depths to groundwater in Smith Valley are measured by NDWR semi-annually and also reported by other entities. Data for active monitoring well sites (Figure 2) can be found on NDWR's website at <http://water.nv.gov/WaterLevelData.aspx>, or via the Nevada Hydrology Data Mapping Application, accessible at <http://water.nv.gov/mapping.aspx>. Groundwater level data are also collected by USGS and may be accessed through their website at <https://waterdata.usgs.gov/nv/nwis/gw>.

## METHODS TO ESTIMATE PUMPAGE

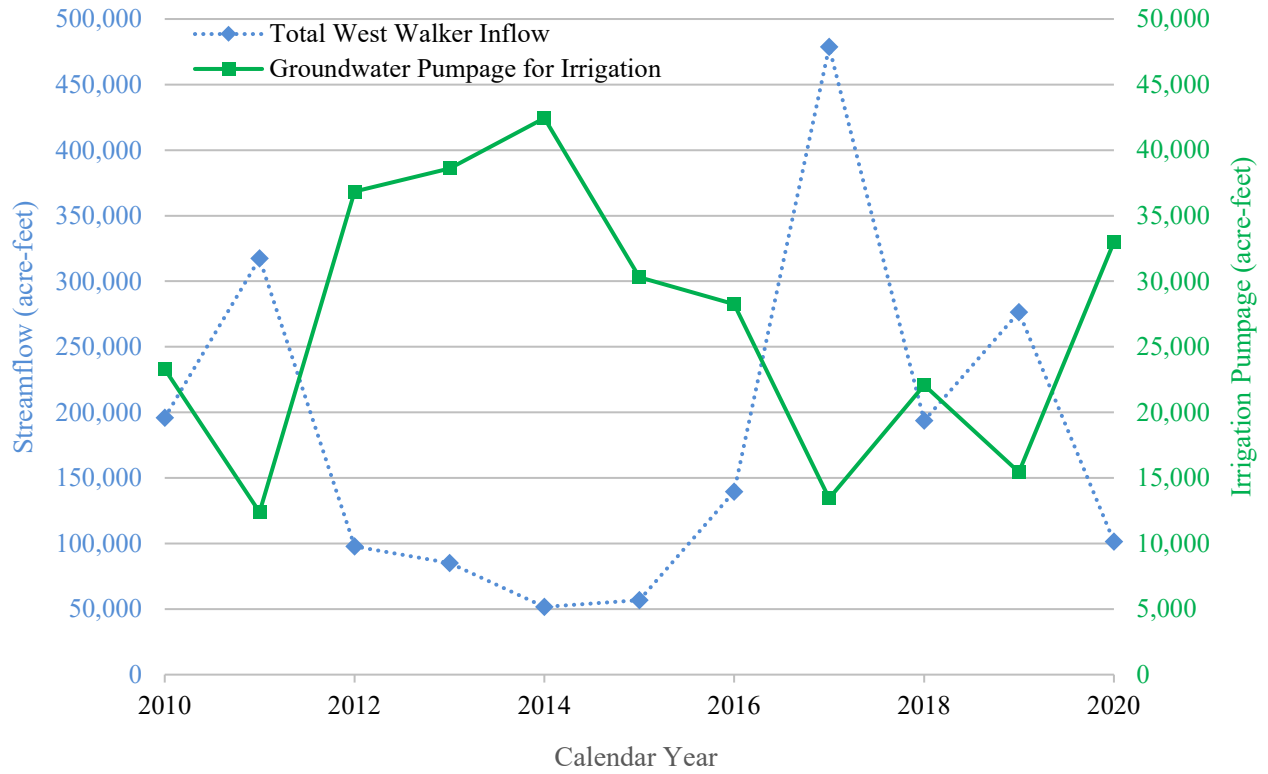


Figure 3. Smith Valley historical irrigation pumpage compared with West Walker River stream flows at USGS gauging station #10297500 at Hoye Bridge.

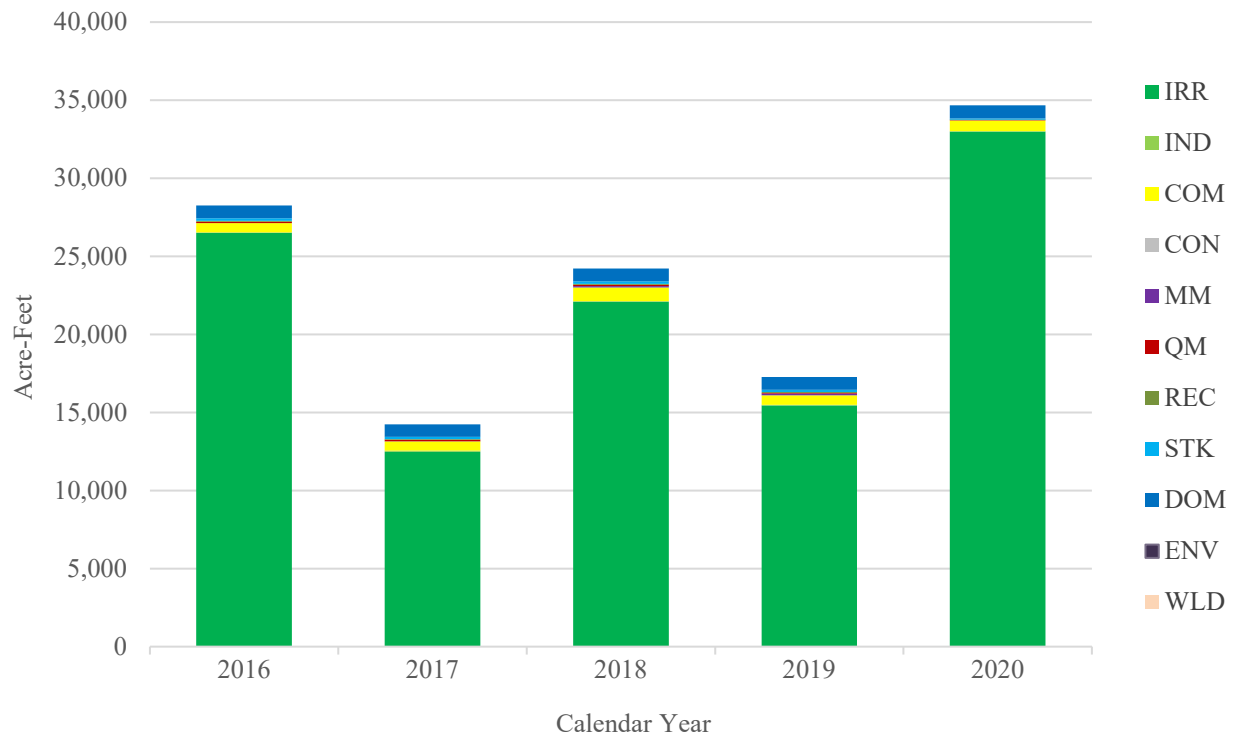


Figure 4. Smith Valley historical pumpage by manner of use.

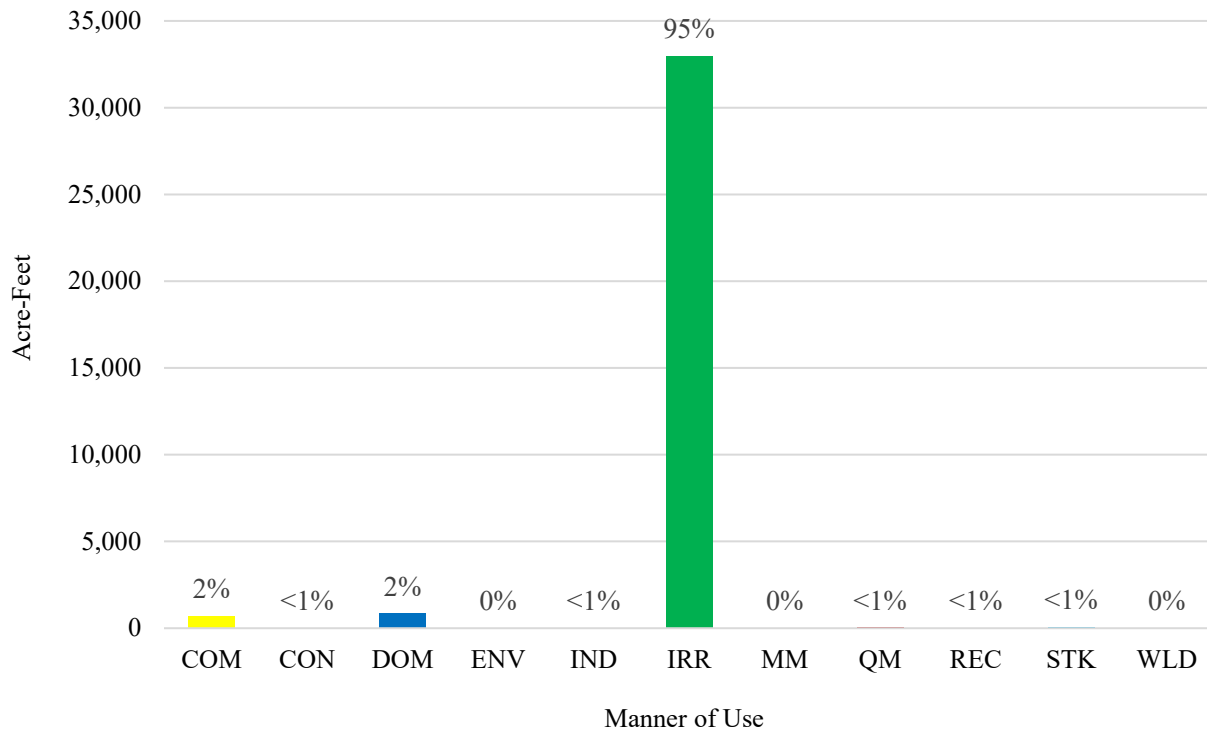


Figure 5. Percentage of total 2020 groundwater pumpage by manner of use.

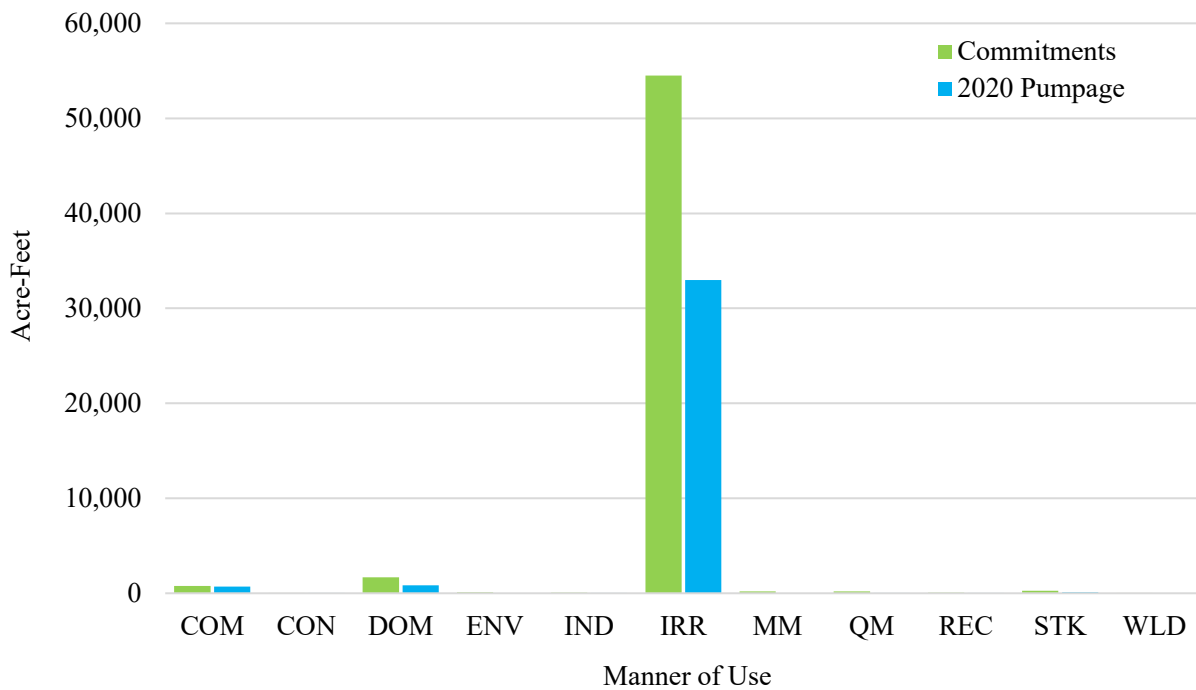


Figure 6. Comparison between 2020 groundwater commitments and estimated pumpage.

One of the purposes of this report is to estimate the amount of groundwater pumped under vested claims, permits and certificates issued by the State Engineer, as well as the amount pumped by the exempt domestic wells in the valley. Table 1 and Figure 4 show historical pumpage by manner of use; Figure 3 shows historical pumpage for irrigation compared with West Walker River stream flows; Figure 5 shows the percentage of water pumped by manner of use; and Figure 6 compares groundwater commitments and estimated pumpage by manner of use. The following methods were used to arrive at the estimated use:

- Where totalizing meters were in place, meter readings were taken and compared with previous data (if available).
- Where water rights owners are required to provide the Office of the State Engineer with monthly pumping totals as a condition of their permits, these reports are verified with meter readings taken by NDWR staff and used as the amount pumped.
- Where meters were not in place and the use was irrigation, pumpage was estimated by multiplying the number of hours the well was operated during the past year (determined from an hour meter reading or asking the water user) by the certificated diversion rate.
- Where totalizing meters were present, and irrigation was observed, but readings resulted in inconsistent usage figures, meter readings were interpolated/extrapolated to compute an estimated use. Where there were no flow meters or other reliable options for estimating pumpage and the use was irrigation, pumpage was estimated by dividing the Net Irrigation Water Requirement (NIWR) for the crop grown by the efficiency of the irrigation method used, then multiplying by the number of acres irrigated. Irrigation efficiencies associated with three types of irrigation methods are pivot at 85%, wheel line or other hand moved sprinklers at 75%, and flood at 60%. The pumpage amount estimated by this method was limited by the duty of the permit. For places where the groundwater rights are supplemental to surface water, groundwater use was estimated using the NIWR method above, but adjusted based on available surface water for the year. Evapotranspiration and NIWR data by basin can be found on the NDWR website at: <http://water.nv.gov/Evapotranspiration.aspx>.
- Where meters were not present, previous data were not available, and the manner of use was not irrigation, pumpage was estimated by applying the annual duty associated with the certificate (if the water right was perfected), permit or claim, if the use was as described in the certificate, permit or claim. If the use was not as described in the certificate, permit or claim, a value was estimated based upon the circumstances of use for the subject year.
- Pumpage estimates for stockwater wells were derived from field investigations, information from the Bureau of Land Management's [Rangeland Administration System](#), documentation from the water right files, and the certificated duty for the water right.
- Exempt domestic wells may be drilled and utilized where water service from a purveyor is not available. These types of wells do not require a permit from the State Engineer if they do not pump more than 2 acre-feet per year as provided by Nevada Revised Statutes (NRS) [534.180](#). [NRS 534.013](#) defines this category of domestic use as follows: *“Domestic use or domestic purposes extends to culinary and household purposes directly related to a single family dwelling, including, without limitation, the watering*

*of a family garden and lawn and the watering of livestock and any other domestic animals or household pets.”* The number of exempt domestic wells in the basin was determined by a query of the NDWR Well Log Database. The amount of water pumped annually by exempt domestic wells is estimated to be 1 acre-foot per well in Smith Valley, or 842 acre-feet.

SITE NAME	An ID assigned to each well based on its geographic location.
APP NO.	The file number of the Application to Appropriate/Change Water.
STATUS	Indicates if the application is a permit (PER), claim of vested right (VST), or if it has been certificated. For certificated applications, the certificate number will be listed in the column.
MOU	The manner of use of the appropriated water.
