Reich served as the 22nd Labor Secretary under President Bill Clinton and currently is an economic advisor to President-elect Barack Obama. Reich is professor of public policy at the Goldman School of Public Policy at the University of California at Berkeley. He has written 11 books, most recently Supercapitalism. His articles have appeared in The New Yorker, Atlantic Monthly, New York Times, Washington Post, and Wall Street Journal. Reich is co-founding editor of The American

Berkshire Hathaway Chairman and CEO Warren Buffet. Google CEO Eric Schmidt, **XEROX** CEO Ann Mulcahy, former Federal Chairman Reserve Paul Volcker. who will head the incoming president's Economic Recovery Advisorv Board. and former Treasury

Secretary Larry Summer, who will head the National Economic Council in the new administration.

As Labor Secretary, Reich implemented the Family and Medical Leave Act, led a national fight against sweatshops in the U.S. and illegal child labor around the world, and launched job-training programs, one-stop career centers and school-to-work initiatives. Under his leadership, the Department of Labor won more than 30 awards for innovation. In 1996, he was rated the most effective cabinet secretary during the Clinton administration by Hearst newspapers. He is also the recipient of the prestigious Vaclev Havel Foundation Prize, awarded by

# Alternative lending options becoming increasingly attractive to small businesses

ast month, in our continuing series on alternative lending options for small businesses, we examined the pros and cons of credit card financing, family & friends and home equity loans. This month we'll tackle to best and worst of some other options including peer-to-peer lending, strategic use of personal savings, and government-backed loans.

#### **Personal Savings**

**Pros:** Utilizing your private savings for business start-up or expansion financing has a number of obvious benefits: immediate access to capital, elimination of the loan qualifying process; no interest rates to negotiate and no loan to pay back on a pre-determined timetable. Unlike tapping your home equity or 401(k) plan, your loan won't be impacted by the whims of global financial and real estate markets. Perhaps the most attractive feature of this funding option is that you have no one to answer to from a financial perspective – the money is yours to use as you see fit.

**Cons:** There are just as many corresponding downsides to the benefits noted above. Launching a business without going through the traditional business plan and market analysis required by traditional lending institutions can put you at risk for failure; due diligence is vital to pre-launch research regardless of where your funding is coming from. Tapping your savings also reduces or eliminates both your personal and business financial safety net. Will you be using money previously earmarked for a child's education or retirement? A good compromise is to spread the risk broadly, when possible, which includes assembling necessary funding from a variety of alternative financing sources: personal savings, family & friends, and where prudent, HELOC (Home Equity Line of Credit) or 401(k) savings plans.

#### **Peer-to-Peer Lending**

**Pros:** Peer-to-Peer, or P2P lending, is quickly gaining attention for its efforts to match borrowers who don't qualify for traditional financing with investors looking for a better rate of return than offered by many of the usual savings and investment options. According to a recent article by Laura Bruce at *Bankrate.com*, the three main P2P lending companies in the U.S. - Prosper, Zopa and Lending Club - anticipate final 2008 lending figures will approach \$100 million. P2P creates a win-win, where businesses can get unsecured loans financed while investors pursue a better yield on cash.



**FICTION:** Southern Nevada's groundwater project will turn rural Nevada into a desert wasteland.

FACT: Rural communities, ranchers and wildlife are protected by Nevada water law and federal environmental law. In an effort to reduce our community's 90 percent dependence on the drought-plagued Colorado River, the SNWA will draw upon unused groundwater supplies within Nevada. The SNWA is proposing to access water that is naturally replenished each year — just as farmers and eastern Nevada residents do. The SNWA will install a system of wells to sustainably manage the withdrawal of available, unused groundwater, and the project will be overseen by federal agencies including the U.S. Fish & Wildlife Service and the Nevada State Engineer. The bottom line is that the SNWA is committed to responsible groundwater management — and the law demands it.





# New changes to ADA law place bigger burden on employers

he ADA Amendments Act of 2008, which goes into effect January 1, 2009, broadens the scope of protection provided to individuals under the Americans with Disabilities Act (ADA) of 1990. Some the changes will place new burdens on employers.

According to the U.S. Equal Employment Opportunity Commission (EEOC), the ADA prohibits employers from discriminating against disabled employees and requires employers to provide "reasonable accommodations" for individuals with disabilities, unless the accommodation would cause "undue hardship" on the operation of the employer's business. Through the Amendments Act, Congress has shifted the focus in such a way that the onerous is less on whether an individual qualifies as "disabled" under the law – which has been difficult for many business owners to positively define - and more on whether employers are complying with their ADA obligations.

What does this mean to your business? As an employer, you could be held liable under the ADA if you discriminate against an employee because of a

"perceived impairment," as many employees who were not previously protected under the ADA may now be considered legally "disabled." Here's what you can do to protect yourself:

- 1. Familiarize yourself with the new stipulations outlined in the ADA Amendments Act of 2008 by visiting *www.eeoc.gov*.
- 2. Involve your human resources department in ensuring your hiring and firing procedures reflect and are compliant with the changes to ADA law.
- 3. Anticipate the possibility that employees who previously were not seeking ADA accommodations ask for exceptions.
- 4. Where applicable, seek legal advice to ensure your policies are ADA compliant.

## Chamber outlines reform agenda for 2009 legislature

Ince 1911, the Las Vegas Chamber of Commerce has been driving public policy on behalf of the business community, helping Southern Nevada become a thriving and dynamic marketplace full of opportunities. The Chamber has a long history of advocating for low-tax, pro-business policies that help businesses grow, create jobs and reinvest in our economy. The Chamber also has a history of community stewardship, supporting programs and services that are important for a healthy community such as bonding for school construction and resources for education excellence, water infrastructure and transportation. For this legacy of stewardship, I am proud to be a part of the Chamber.

As you are all too well aware, we are experiencing an unprecedented economic downturn that is putting tremendous stress on our community. The current two-year state budget of \$7 billion has already been cut by \$1.2 billion, and lawmakers will have to reduce it by another \$331 million to get us through the remaining months of this state budget cycle which ends June 30, 2009.

The Economic Forum, the body that establishes state revenue projections, met this week and made some sobering, yet legally-binding, state revenue projections for the coming two-year state budget cycle. The Forum projected that Nevada's revenue for the next two years (2009-2011) will be \$5.65 billion (\$2.782 billion for 2009-10; and \$2.874 billion for 2010-2011). That number is roughly 19 percent below the current state budget.

The forecast for the next two years is bleak. Revenues from the gaming tax and the two percent state sales tax represent about 60 percent of all state general fund revenues. Neither revenue source is forecasted to make a complete comeback in the next two years, requiring alternatives to be found.

With the cuts already made to the state budget, there will be a limit to the amount of spending that can be reduced without undermining the core services provided by the state. Most of the budgeted one-time expenditures have already been eliminated. Most, if not all, agencies have imposed hiring freezes. The reality of the current economic situation means that critical state services and programs such as education are suffering, and further cuts will be even more painful.

This year, the Chamber commissioned a series of reports analyzing state and local government spending, particularly in terms of public employee salaries and benefits. The reports found that the Nevada Public Employees' Retirement System (PERS) and Public Employees' Benefits Program (PEBP) are some of the most generous benefits

in the country and together have a \$10 billion unfunded liability. The Chamber believes that PERS and PEBP must be reformed to protect the long-term fiscal health of our state. This much-needed reform, however, will not offer the short-term solution that is needed to address current statewide economic challenges and fund the next state budget. Given the severity of the current economic crisis, coupled with the significant cuts that have already been made, it is likely that more revenue will need to be raised if this crisis continues. I do not say that lightly.

Every sector of our community has something at stake as we face these extremely challenging times, and so we all need to be part of the discussion. Reform of PERS and PEBP is essential to our state's future. And labor and business must both be willing to make concessions for the good of our community, for the good of our children and for the long-term health of our state. Small businesses, the fabric of our economy, must be supported. This is the time to address both our short-term needs and reform long-term fiscal problems, putting our state back on a viable, sustainable fiscal path.

The Las Vegas Chamber of Commerce wants to hear from our members on this important issue. Our incoming Chairman of the Board Steve Hill, will hold a series of members-only meetings so that you can share your ideas. But I believe that if we work together, address these challenges together, make the difficult decisions together, our state and our community will not only endure this current economic recession, we will come back stronger than ever.

F. Kennedy School of Government and of Brandeis University. He received his B.A. from Dartmouth College, his M.A. from Oxford University, where he was a Rhodes Scholar, and his J.D. from Yale Law School.

Reich will join fellow Preview presenter Commissioner Jon Wellinghoff, a member of the Federal Energy Regulatory Commission (FERC). FERC is the agency that oversees wholesale electric transactions and interstate electric transmission and gas transportation in the United States. He was sworn in by Senate Majority Leader Harry Reid in 2006 and was recently reappointed to a second term.

Commissioner Wellinghoff is an energy law specialist with more than 30 years experience in the

field. Before joining FERC, he was in private practice and focused exclusively on client matters related to renewable energy, energy efficiency and distributed generation. While in the private sector, Commissioner Wellinghoff represented an array of clients from federal agencies, renewable developers, and large consumers of power to energy efficient product manufacturers and clean energy advocacy organizations.

While in private practice, Commissioner Wellinghoff was the primary author of the Nevada Renewable Portfolio Standard (RPS) Act. The Nevada RPS is one of the two states to receive an "A" rating by the Union of Concerned Scientists. In addition, he worked with clients to develop renewable portfolio standards in six other states. The commissioner is considered an expert on the state renewable portfolio process and has lectured extensively on the subject in numerous forums including the Vermont Law School.

His experience also includes two terms as the State of Nevada's first Consumer Advocate for Customers of Public Utilities. While serving in that role, Commissioner Wellinghoff represented Nevada's utility consumers before the Public Utilities Commission of Nevada, FERC, and in appeals before the Nevada Supreme Court. While Consumer Advocate, he authored the first comprehensive state utility integrated planning statute. That statute has become a model for utility integrated planning processes

across the country.

Wellinghoff holds a B.S. in mathematic from the University of Nevada, Reno and completed his masters in mathematics from Howard University in Washington, D.C. In 1975, Wellinghoff received a law degree from Antioch School of Law in Washington, D.C.

**Cons:** A number of regulatory issues are still in play with regard to P2P lending, making it vital that care is taken in investigating this alternative lending option. Most companies keep current data on defaults and other important statistics. Most also provide detailed Q&A sections and step-by-step instructions of how borrowing and lending work.

## Small Business Administration (SBA) & Nevada Microenterprise Initiative (NMI)

**Pros:** The U.S. Small Business Administration (SBA) offers a wide range of government-backed loan programs for small businesses. In fact, SBA's FY 2009 budget request will support a total of \$28 billion in small business financing, which represents a 37 percent increase over business lending for FY 2008. "Microloans" are also available through Nevada Microenterprise Initiative (NMI), a private nonprofit community development financial institution. NMI loans can be used for start-up and business expansion, including equipment, inventory, supplies and some working capital. Both the SBA and NMI provide consultation services

free of charge.

**Cons:** There is really no downside to securing business financing through SBA or NMI – it is simply a more rigorous process than other forms of alternative lending, and like other forms of traditional finance, is subject to greater scrutiny and documentation than ever before. Applicants will be required to provide detailed information about their business plan and business model, as well as demonstrate strong personal credit histories.

In the next issue of *The Business Voice*, we'll start examining equity lending options in the form of venture capital and angel investing.


