

GOVERNMENT AFFAIRS AND PUBLIC POLICY



When does the 2019 State Legislature begin?

Per the Nevada Constitution, the Nevada State Legislature will convene on the first Monday in February, which is Feb. 4.

What is the composition of the State Legislature?

The State Senate and Assembly majorities are both held by Democrats. Thirteen Democrats and eight Republicans in the State Senate and 29 Democrats and 13 Republicans in the State Assembly. The Democrats are one seat short of a super majority in the State Senate. The Democrats have a super majority in the State Assembly of more than 2/3 of the seats. Democrats gained two seats in the State Senate and gained four seats in the State Assembly.

When was the last time there was a super majority in the State Legislature?

In 2011, the Assembly Democrats had a super majority with 28 members out of 42 Assembly seats.

How many freshmen members will be in the State Legislature?

There is a total of 11 freshmen

members between the State Senate and Assembly, who have not served in the State Legislature before. There is one freshman in the Senate and 10 new members in the State Assembly. In addition to the 11 freshmen members, there are several Assembly Members that ran for the State Senate and won, such as Assemblyman James Ohrenschall and Assemblyman Keith Pickard. Former Assemblywoman Marilyn Dondero Loop was elected to the State Senate as well.

What happens to several of the open seats that are in State Senate and Assembly?

State Senator Aaron Ford has been elected to serve as Nevada's next Attorney General and State Senator Tick Segerblom has been elected to the Clark County Commission. Both of these Senators will need to resign from the State Senate before they can be sworn-in into their new offices. The Clark County Commission will take applications and make an appointment to each of the open seats. Since Senators Ford and Segerblom are both Democrats, the Clark County Commission must appoint a Democrat to the vacant seats.

In regard to Assembly District 36, voters elected Republican candidate

Dennis Hof. Hof died unexpectedly in October, but his name remained on the ballot. His replacement will need to be a Republican from Assembly District 36, which contains parts of Clark, Lincoln and Nye Counties. Nevada State law requires that the three County Commissions within Assembly 36 make a joint decision.

When will the Metro Chamber release its legislative priorities?

The Metro Chamber will formally release its 2019 legislative priorities on Feb. 1, 2019. Those priorities will be focused on the business climate, education, economic development, governance structure, transportation infrastructure and taxation.

Who decides the Metro Chamber's legislative priorities?

The Metro Chamber's legislative and policy priorities are developed by its Government Affairs Committee. This is a group of Metro Chamber members who analyze issues and make determinations that guide the Metro Chamber's positioning on matters to promote fiscal responsibility at the state and local government levels, improve the education system and strengthen the business environment and economy in Southern Nevada.



epression has become more discussed in recent years, which is fortunate because according to the World Health Organization,

more than 300 million people suffer from depression across all ages. It is commonly believed that depression increases during holidays. Depression is important to address because it can lead to suicide. While clinical depression may not be diagnosed, many people experience symptoms of depression at some point in life. In effort to alleviate effects of depression, there are tools for healthy coping. Firstly, if someone is experiencing depression: talking to a counselor. It helps to have an objective, trained professional support in finding and utilizing effective strategies.

The most common symptoms of depression include self-isolation, not finding enjoyment in typically enjoyable activities for the individual, insomnia or sleeping excessively, excessive eating or loss of appetite, and fatigue or restlessness. Depression can look different for each person. Pay close attention to negative thought patterns, feelings of guilt without reason, helplessness,

hopelessness and worthlessness. Depression causes difficulty thinking, concentrating and making plans. Finally, thoughts of suicide is a great indicator of depression even when no plan is made.

A person may function daily for a long period of time with symptoms of depression while stress and triggers continue to build until a major crisis happens. In order to prevent such crises, it is necessary to pay attention to people, listen to what they say, notice changes in behaviors and make it priority to genuinely be concerned with the livelihood of others. In doing so, it only takes caring and asking open ended questions to "check-in". In the event the person opens up and admits to symptoms of depression or suicide, get professional help.


As holidays approach and life stressors occur, self-care is critical to getting ahead of depression. Be sure to engage in physical activity for at least 30 minutes daily; being in nature is advised. Find activities that are enjoyable and bring laughter. Spend time with loved ones and friends, especially during holiday season. If the holidays (or life) tend to be lonely, plan ahead

to avoid isolation and loneliness. Be aware of food consumption. Eating nutritiously for energy needed; food is your fuel. Be mindful of alcohol and substance intake especially with the increase of social activities and parties during holiday time. Keep a steady routine and get enough sleep as well as rest and relaxation to destress. Employ meditation, prayer and/or practices that free your mind. Engage in journaling, listen to music and find ways to express thoughts and feelings for increased self-awareness. Finally, believe in yourself and know that you have a purpose that is worth living for. If you struggle to believe this, start by saying it now: I am worthy. My life has a purpose. I choose to live.

Daily positive affirmations are critical to shape thinking and improve positive feelings. As always, do not be afraid or ashamed to ask for help. If you are experiencing suicidal ideation, call the national suicide prevention hotline: 1.800.273.TALK.

I knew I wanted to interview him about what the long-closed hotel-casino meant to him and why. To Deverynn Bryant and Katherine Duncan, this property was an opportunity to repair race relations. After it burned on Oct. 5, I added audio from a town hall meeting where community members still spoke of bringing it back. Why does the government not invest in the Historic Westside in a way that benefits the area? People at that meeting echoed what Deverynn had already spoken of. They believe officials and the larger community don't care to preserve their history or assist in their struggles. I hope someone will see the film and decide to help the Westside in some way, even if that never brings back the Moulin Rouge.

of an experienced business mentor? Do you know that SCORE exists to help you? SCORE's Mission is to "Foster vibrant small business communities through mentoring and education".

What is SCORE?

SCORE, founded in 1964, is America's premier source of free and confidential business advice for entrepreneurs and small businesses. SCORE is a nonprofit resource partner of the U.S. Small Business Administration (SBA). With more than 10,000 volunteers supporting 300-plus chapters across the country, SCORE has the resources to deliver the help you need through mentoring and education. Locally, the Las Vegas chapter has more than 60 volunteers ready to serve Southern Nevada businesses at several mentoring locations.

2019 - What's your plan?

As a leader in your business, one of the most beneficial things you can do is to create an annual business plan and use it to manage your operation.

Your business plan should set your objectives for the year, define the strategies and tactics you will use to meet the objectives and set your priorities. It may seem like a daunting task, [but] it doesn't need to consume many hours of work. Commit time to think about where you want the business to go and how to get there. Need guidance? Meet with a SCORE mentor to get helpful direction.

Writing a business plan is an opportunity to:

- Carefully think through every step to achieving your goals for your company
- Discover any weaknesses that may threaten your business
- Identify opportunities you may have not considered and plan how you will deal with challenges that are likely to arise.

What does SCORE offer?

SCORE provides free business advice through our network of experienced business mentors. Our certified mentors employ a methodology referred to as "SLATE" to understand your business and the issues you face such as developing your annual plan or other issues like marketing, finance or operations.

While face-to-face mentoring meetings usually occur at a local mentoring office, other arrangements can be made to meet at an alternate site. There is a concept that has been around for many years. It states that after 10,000 hours of practicing a particular skill, you can finally be considered a master of it. To break this down, one must work 40 hours per week, 50 weeks per year, for five years to obtain 10,000 hours of "practice" time. Yet, we do not often look at people who have been in their careers for five years as masters of their craft, nor do many of us feel we have mastered our chosen profession after only five years of work. Furthermore, we would not consider someone a master of their craft for very long, if they only practiced for the requisite 10,000 hours, and did not continually hone their skills or improve with the changing environment.

We expect someone who is considered an expert in their field to be constantly improving, to always be searching for the newest developments in their industry, and to stay in tune with the best practices of their area of expertise. It is easy to spot the person who is just punching the clock; the person who is just collecting a check; the one who has not yet found their passion in a career.

Anyone who has successfully studied for a particular field and completed the requirements for obtaining a degree, license or certification for their specific industry has experienced the wonderful feeling of reaching the goal, and most likely the brief feeling of being an expert in that moment, Quickly, we almost all come to the realization that learning has really only just begun. Whether the industry is constantly changing or the training was just to provide the theoretical understanding of the craft, people new to a particular field quickly find out that in order to really become a master - and then to stay one - they are going to need to adopt a mentality of becoming a life-long learner. Times change, new technology and understanding are developed, behavior adjusts and the old way of doing things quietly becomes obsolete, or even detrimental. Anyone who does not take the time to learn the latest trends or nuances of their industry will quickly fall behind.

Continual learning comes in many forms and varies across the job market. In some careers, seminars and lectures are regularly offered. In others, additional formal schooling
