ADMINISTRATION (ALAN)

1. Manned the booth at the Geothermal Resources Council annual meeting at the Peppermill in Reno.

3. Discussed deliverables expected from claim post pulling grant with Lois Ports of Bristlecone Nevada.
4. Answered questions from claimant/investor Dick Herrmann looking for information on exploration logistics and assistance in southern Nevada.
5. Provided a “Stay Out, Stay Alive” presentation to the joint Douglas County and Carson City Search and Rescue squad in Minden with John. (1 presentation – 20 people)
6. Reviewed and researched BLM 2012 closures list from Chris Ross for completeness and requested additional information to assign NDOM numbers to those without.
7. John and I met with Cindi Byrns (Comstock) to discuss their plans for additional mine closures and remediation efforts. Logged one hazard and non-hazard near Gold Hill Hotel.
8. Attended geothermal meeting led by Lowell to review Gradient Resources’ proposed water monitoring plan presented by Alan Welch (7Q10). Representatives from Churchill County, NDEP, DWR and BLM were also present.
9. Worked with Alan on Annual Status and Production final numbers and data for Major Mines publication.
10. Valerie continued working with David Davis (NBMG) on collecting missing 2011 production reports from non-metallic producers.
11. Answered questions from, and provided historical information and Internet links to, Jasmine Vittori (JBR) regarding the Yellow Jacket mine shaft and surrounding features. Comstock is preparing to remediate and salvage some historic features and JBR is working for them and with the Comstock Historical Society to accomplish this.
12. Answered questions from BLM-CC regarding our request to secure 13 mine features in the Pine Nut Range east of Gardnerville.
13. Communicated with Mine Safety and Training Section to accommodate NDOW biologists and other interested AML participants at next week’s MSHA Underground Annual Refresher class.
14. Attended the MSHA Underground Annual Refresher class taught by the Mine Safety and Training Section.
15. Communicated with BLM-CC regarding planned gating work in Pine Nut Range which unfortunately could not be authorized due to archaeological clearance requirements within the time frame required by NDOW. Closures will be postponed until next year.

16. Spoke with Chris Ross (BLM-NSO) and contract archaeologist Stephanie Livingston (GBI) regarding best procedures for future NDOM requests for hard closures, availability, funding, and scheduling.
17. Coordinated with EPS and Washoe County to conduct PUF closure work next week at shaft on county-owned site near Mustang.
18. Provided hazard ID sheets and photographs to Whitney Wirthlin (BLM-Elko) to complete requisite closure reports for sites at Spruce Mountain.
19. Assisted John with MS Access data entry and AML photo file entry, edit, and archiving procedures.

AML / PUBLIC AWARENESS - NORTH (JOHN)

1. Mike Visser and I met with Cindi Byrns, Director of Environmental and Regulatory Management with Comstock Mining in Gold Hill regarding AML closures on the Comstock.
2. Mike and I logged the Yellow Jacket shaft at Gold Hill for AML closure.
3. Mike and I reviewed and discussed the equipment and supplies needed while in the field on AML projects.
4. Performed research on potential AML sites in Esmeralda, Mineral, and northern Nye counties for field visits next week.
5. Witnessed and assisted Bill Durbin in closure of the Mizpah Mine vent raise air shaft which reopened in the parking lot of the Tonopah Historic Mining Park. Brian Breiter of EPS and his assistant Jeremy completed the polyurethane foam closure. The work was documented through video and time lapse photography by Ted Faye of Gold Creek Films. Persons interviewed for the video were Brian Breiter, Bill Durbin, Mimi Rodden and James Eason.
6. Took measurements with Bill at the Tonopah Historic Mining Park for additional AML safety/security fencing proposed by staff at the Park.
7. Conducted and completed land status research with Bill for the 11 hazards at the Esmeralda County courthouse in Goldfield.
8. Investigated and ranked with Bill 11 hazards and logged 6 non-hazards in Esmeralda County just outside of Tonopah. One shaft was fenced with a hazard rank of 10; at a second shaft the old fence was repaired and new warning signs were posted; two signs were posted at a minimal hazardous third shaft found next to a road; a warning sign was added to an existing fence at a fourth shaft.
9. Conducted field visits on potential AML sites on the Klondike and Mud Lake Quadrangles in Esmeralda County, but was turned back by rain and muddy, hazardous conditions. Field visits were also performed on AML sites in the Downeyville and Quartz Mtn. Quadrangles in northern Nye County; a warning sign was added to replace a stolen one at a shaft. Further work is warranted at some of these visited sites.
10. Witnessed and assisted as well as kept an eye out for any possible fire sparked by machine dirt work in the closure of the Shively Strike Abandoned Mine Lands Permanent Closure Project. The project was located on the NE flank of Winnemucca Mountain in Humboldt County. Brian Breiter of EPS and his team completed the backfill and polyurethane foam closure. The backfill work was done with a Cat track hoe and a Cat D7 dozer. A water truck was also used for dust suppression and as a precaution in case of a fire. A total of 5 hazards were backfilled and permanently closed, one of these was a

polyurethane foam/backfill closure. The slope over the “former” hazards was well contoured and tracked and is ready for reclamation seeding. The project took three full days which is one full day sooner than expected. These newly secured hazards are NDOM #'s HU -29 through HU-33.

11. Approximately 100-120 t-posts were able to be saved and recycled from the Shively closure project.
12. Met with Chris Ross at the Shively site, he is the Abandoned Mine Program Lead with the BLM. Chris had BLM oversight of the Shively Strike project.
13. Performed AML prospecting and re-visits at the Jessup Mining District in Churchill County. Repaired one fenced shaft, replaced signage and posts at a minimal hazard adit, and replaced 2 missing signs at 2 other adits.
14. Performed AML prospecting and logged seven AML hazards and 2 non-hazards in the Lodi Hills of northern Nye County on the Quartz Mtn. topo quadrangle.
15. Assisted Mike Visser with AML presentation to Douglas County/Carson City County new Search and Rescue trainees at the Douglas County Sheriff in Minden. There were 20 attendees.
16. Attended GSN October monthly meeting in Reno.
17. Attended MSHA underground refresher course in Carson City.
18. Spent time learning and entering AML data sheets into the Access database with Mike Visser. Entered Nye County logged hazards and photos from 10-22-2012.

AML / GIS (RACHEL)

1. Completed monthly back up and data management of all AML data and shared drives. Updated the AML photo archive and backed up copies to removable drives.
2. Received information from Stephanie Livingston regarding new sites logged in the area of the Sulphur Mine in Pershing County. Cross referenced these hazards with ones previously logged and determined they were new sites. Assigned new numbers to 16 hazards and updated the database with the new information.
3. Spoke with Adam Knight at the Springer Mine in Pershing County regarding the inventorying of AML features on claims controlled by Springer. Provided Mr. Knight with our hazard and non-hazard inventory forms, AML FAQ forms and information on existing hazards in the area. He will begin logging new hazards and submit the new information to us.
4. Received an inquiry from Ken Maas with the USFS regarding sites in the Manhattan and Gabbs areas of Nye Counties. Cross referenced photos with those provided by Ken Maas and assigned new numbers to those hazards that had not been logged by NDOM. Received securing information from Ken Maas regarding backfill projects that were completed on USFS land in the Manhattan area. Added the new information to the database and updated the photos.
5. Worked on addressing projection issues in ArcMap 10.1. Found that problems were occurring with the projection of our hazard and non-hazard databases when there were features missing UTM data. Worked with ESRI personnel to find the cause of the issue. Worked with Debbie Selig to find a work around for this issue.
6. Added new hazards logged by EPS in White Pine County to the database.

7. Reviewed adding new hazards and non-hazards to the database with John Penton. Also went over the procedures for adding photos to the database, updating the weekly mines and adding database points to the GPS units.
8. Conducted QA/QC on hazards and non-hazards recently logged. Found that two hazards were plotting in counties other than the counties they were logged in. Researched these discrepancies further to discover that the hazards had been logged in incorrect counties. Amended the database to reflect the correct county data and updated the photos accordingly.
9. Spoke with Russ Jones at Barrick regarding logging and securing of AML features on Barrick claims. He was interested in learning more about our Summer Intern program in hopes of acquiring his own interns. Suggested that we would be willing to assist in field work for a few days in order to ensure the work being completed by Barrick personnel contained all the information we needed.
10. Completed laptop maintenance – uninstalled all Microsoft Office software from the old laptop and installed it on the new one for future use.
11. Researched the possibility of adding geotagged photos to ArcMap for review when creating maps. With ArcMap 10.1 it is possible to add a geotagged image to the map – it will create a point and display the photo of the hazard in question. Unfortunately, the standard license of ArcMap is needed to view the photos. Began looking into the pros and cons of upgrading our ArcMap license.
12. Completed maps showing the recent work completed for the upcoming CMR meeting.
13. Worked with Valerie Kneefel on developing a database in order to track the placement of the large AML yellow signs being installed on public lands.
14. Revised the shapefiles showing the proposed closure work for the sites in the Pine Nut Range. Updated the spreadsheet and sent it to Chris Ross for review.
15. Received a request from Stephanie Livingstone at Great Basin Institute for photos and logging sheets showing 12 hazards on the Sulphur Quadrangle in Pershing County. Assembled the information and submitted it to her on disk.
16. Received securing information from Hycroft regarding backfills and PUF closures that were completed in early October on the Sulphur Quadrangle in Humboldt County. Updated the database with the new securing information, added the photos to the archive and sent a thank you letter to the claimants acknowledging the work completed.
17. Worked on addressing logging discrepancies with sites submitted to NDOM by the National Park Service in Death Valley. Will be working on assessing if sites logged are hazardous or not and what sites need additional information.
18. Traveled to Elmcrest Elementary School in Reno to teach Rocks, Minerals and AML to two 3rd grade classes with Valerie Kneefel. A total of 46 students were taught about rocks and minerals, the importance of mining in Nevada, and “stay out, stay alive” (2 presentations – 46 people).

1. Logged in AML re-visit information and photos from Jeff Herrera for work in Lincoln County.
2. Participated in the bi-monthly progress report conference call for the BLM/ACOE/BOR AML closure projects – Lincoln and White Pine Counties. Received and logged in the last 7 Lincoln County mine closures.

3. Logged in claimant/property owner securings and photos for 1 site in Lincoln County and 11 sites in White Pine County.
4. Witnessed and assisted in closure of the Mizpah Mine air shaft at the Tonopah Historic Mining Park (NY-2035). Brian Breiter of EPS completed the polyurethane foam closure. The work was documented through video and time lapse photography by Ted Faye of Gold Creek Films. Persons interviewed for the video were Brian Breiter, Bill Durbin, Mimi Rodden and James Eason.
5. Took measurements at the Tonopah Historic Mining Park for additional safety/security fencing proposed by staff at the Park. Prepared a revised fencing assessment for James Eason and Mimi Rodden.
6. Investigated and ranked 11 hazards and logged 6 non-hazards in Esmeralda County. Land status research for the 11 hazards was completed at the Esmeralda County courthouse. 8. Traveled to Mormon Mountains Wilderness area in Lincoln County with BLM and BATFE personnel to witness disposal of old explosives found in a natural cave by a BLM wilderness ranger. Ten sticks of 1964-vintage ANFO based powder destroyed.
9. Investigated, ranked and secured one hazard and logged three non-hazards in the Mormon Mountains Wilderness area – Lincoln County.
10. Prepped materials for Southern Nevada National Trail Days Celebration event – scheduled for Saturday, October 6. Set up display at Southern Nevada National Trail Days Celebration event - Henderson. Bill and Debbie manned the display visited by approximately 200 people.
11. Completed inventory of materials and supplies at Las Vegas office and storage unit for the 2013 Las Vegas teacher workshop.

2. Reviewed Major Oil's sundry notice to add additional perforation and testing intervals to the Eblana 1 testing program. Received BLM notification of approval. Mike approved.
3. Reviewed Winn Exploration's sundry request to use a modified BOP stack for the drilling at Ragged Ridge 30-1 in Railroad Valley. The well is permitted to 7,500 feet. Received BLM notification of approval. Mike approved.
4. Reviewed Makoil's Leoman Springs 1-32 permit application and drilling program. The well is proposed to be located in T10N, R56E, SW4 NW4 Section 1, and drilled to 4,000 feet. Target formation not described. BLM has requested more information on the proposed well, as well as access and the drilling pad.
5. Reviewed Makoil's answers to additional questions pertaining to the Leoman Spring 1-32 proposed well in Railroad Valley. Questions given to Makoil pertained primarily to access road construction, pad construction, geological formations to be encountered, possible lost circulation zones, abnormal temperatures and pressures, and reclamation.

2. Met with representatives from Churchill County on Wednesday, October 10th. Discussed what NDOM, NDEP, DWR, and the BLM cover in their oversight of the geothermal industry. Churchill County is trying to decide if additional geothermal regulations are needed by the county. Eleanor Lockwood, Churchill County Manager, appeared to have been pleased with the discourse of the meeting.
3. Met with Plains Exploration and the BLM.
4. Attended the Interstate Oil and Gas Compact Commission annual meeting in San Antonio, Texas. The meeting took place from October 29th to October 31st. Principal topics of discussion were related to hydraulic fracturing activities in numerous States.
