

# NSBAIDRD Adopts NCARB's IDP Streamline



# STREAMLINE

NSBAIDRD voted to accept the National Council of Architectural Registration Boards' (NCARB) proposed change to the Intern Development Program (IDP) at its March board meeting. This change, referred to as IDP Streamline, will be implemented on July 1, 2015.

The IDP currently requires interns of architecture to document 5,600 hours of experience, with 3,740 of those hours as core requirements in specific architectural experience areas. The remaining 1,860 hours are elective hours. Streamlining of the IDP will remove the elective hour requirement for NCARB certification, with interns being required to document only the 3,740 hours in the existing 17 core experience areas.

In making its decision to propose eliminating the elective hours, NCARB considered several important statistics:

- The average intern currently takes 5 years to complete the hours required for IDP and another 2.2 years to complete the ARE, totaling an average of more than 7 years from graduation to licensure.
- With this reduction in required IDP hours, it is likely that the average intern will take roughly 3 to 4 years to complete their IDP requirements following this change.
- Combined with the time required to complete the Architect Registration Examination (ARE), NCARB anticipates that the average intern will have 5 to 6 years of post-graduation experience prior to qualifying for initial licensure.

experience that is essential for competent practice, and result in a program that is both justifiable and defensible," said NCARB President Dale McKinney, FAIA.

With less than 3 months until implementation of the streamlined IDP, here are some key messages interns should keep in mind:

- The current<u>reporting requirement</u> still applies, so interns should submit experience within 8 months for full credit. Experience reported beyond this period and up to 5 years will be valued at 50 percent.
- Interns will continue to report hours through My NCARB and the <u>My IDP</u> mobile app.
- NSBAIDRD and NCARB recommend that interns continue to report all experience, even after achieving the 3,740 hours required to complete the streamlined IDP. Doing so will help facilitate licensure and reciprocity in jurisdictions that don't accept the streamlined IDP.

NCARB will release an updated version of IDP Guidelines concurrently with the July 1 implementation of the IDP Streamline. Until then, more and updated <u>information</u> can be found on NCARB's website. NCARB has also set up a <u>blog</u>, Frequently Asked Questions Streamline, to assist discussion of the upcoming change.

# 2015 NCARB Regional Summit

The National Council of Architectural Registration Boards (NCARB) held its 2015 Regional Summit March 13-14 in Long Beach, California. Delegates from all six of NCARB's U.S. geographic regions, along with the NCARB Board of Directors and staff, gathered to discuss business concerning the regulation of the practice of architecture. Nevada representatives in attendance



included Chairman George Garlock; Secretary/Treasurer Jim Mickey; John Klai; William Snyder; Greg Erny, currently serving as secretary of the NCARB Board of Directors; and Executive Director Gina Spaulding, currently serving as executive director of the Western Council of Architectural Registration Boards (WCARB) Region 6.

Hosted by WCARB Region 6 (which includes Nevada), 191 delegates were led through a program that included a presentation on how architectural regulation can address natural disasters and climate change, a debate on professional credentials, regulatory leadership development, and remarks from NCARB's President Dale McKinney, CEO Mike Armstrong, and President-elect Dennis S. Ward.

Regions also met individually to conduct regional business, hear from candidates running for NCARB office, and nominate regional directors to serve on the FY16 NCARB Board of Directors. The jurisdictions also provided NCARB with feedback on proposed program changes and resolutions that will be voted on at NCARB's Annual Business Meeting this June.

Note: All Nevada continuing education units (CEUs) must be related to health, safety, and welfare (HSW). Courses approved for Learning Units (LUs) ONLY do not meet Nevada's CEU requirements.

### **Disciplinary Actions** (January 16, 2015 through March 4, 2015)

Inquiries are routinely sent to both registrants and non-registrants for alleged violations of the Nevada Revised Statutes (NRS) and Nevada Administrative Codes (NAC).

There were 3 cases this period that were submitted for board consideration and approved. Additionally, 2 cases were closed because there was no basis for the allegations or the complaint did not fall within the board's jurisdiction.

The following cases were closed by means of settlement agreement. As part of the agreement, respondents agreed to assure compliance with Chapter 623. Should the respondent be involved in a subsequent case and found to have again violated a NRS or NAC, the case may be used as an aggravating factor.

Holding Oneself Out, Advertising, and Unlicensed Practice of Architecture, Registered Interior Design or Residential Design: NRS 623.360.1 (a)(b)(c)

Case Number 15-012N

The allegations against *Charles Pick and Basis Architectural & Consulting* were that they held themselves out as being qualified to practice architecture for a project located in Nevada prior to having a certificate of registration issued by the board. The matter was resolved through a settlement agreement incorporating an administrative penalty of \$2,500 plus investigative costs of \$1,000.

#### Case Number 15-015N

The allegations against *Mark deReus and deReus Architects, Inc.* were that they held themselves out as being qualified to practice architecture in Nevada and engaged in the practice of architecture in Nevada without having a certification of registration issued by the board. The matter was resolved through a settlement agreement incorporating an administrative penalty of \$6,500 plus investigative costs of \$1,000.

#### Case Number 15-016N

The allegations against *George Sarfatty and Sarfatty Associates*, *Ltd.* were that the held themselves out as being qualified to practice architecture and registered interior design and engaged in the practice of architecture and registered interior design for a project located in Nevada prior to having certificates of registration issued by this board. The matter was resolved through a settlement agreement incorporating an administrative penalty of \$7,500 plus investigative costs of \$1,200.
